Assessment and Statement

SZABADICS Zrt. is a well-established Hungarian construction company offering a wide array of services. Their core business areas include: underground construction, surface construction and water engineering structure construction. The group has a strong commitment to social responsibility, reflected in its long-standing emphasis on ethical business practices, employee welfare, and environmental protection. The scope of the verification covers SZABADICS Group and its subsidiaries in Hungary.

SZABADICS Group has carefully answered the questions in the self-declaration and provided documents that support these answers. Their fields of activity are planning, operations, procurement and sourcing.

SZABADICS Group has described its value chain, performed a stakeholder analysis and a materiality analysis based on the ISO 26000 standard, and based on selected goals and sub-goals from the Sustainable Development Goals (SDGs). The goals have been compiled in an "action plan of priority goals".

With the mature application of management systems, several certifications in place and the CSR activities that have been highlighted since its existence, the SZABADICS group can claim a strong foundation in relation to sustainability efforts. In 2023, this was joined by the interest in circular farming and the activity undertaken in a national construction industry working group, and in 2024 by the support of the application possibilities of natural building materials. Its goal is to be the first in the region to play an outstanding role with its sustainability efforts.

A high degree of transparency prevails and good business ethical behavior can be discerned throughout the business. SZABADICS Group shows respect and sensitivity to the interests of stakeholders. Verify Agency has verified all levels of activities that the organization states in the self-declaration. Verify Agency has performed the verification through interviews with the organization's staff and through a sampling of the documentation that the organization refers to in the self-declaration and in the management of its sustainability work such as policies, business routines, analyses, assessments, minutes, surveys, communication efforts, and training. An on-site audit was also performed.
